NEWSLETTER - JULY 2017

It's been a while since the last newsletter. Currently we have 331 members who are on the electoral roll and have supplied all the details required by the Australian Electoral Commission for their membership to be used to register PIBCI as a Federal Political Party.

We have another 462 members who are **NOT** on the electoral roll or who have not supplied all the details required. We **CANNOT** use their membership to register PIBCI as a Federal Political Party.

This means we need another 220 members on the Australian Electoral Roll before we can apply for registration as a Federal Political Party.

This newsletter is being sent to the 331 members on the Australian Electoral Roll as well as being emailed to those who have supplied email addresses who are not on the electoral roll. At a later date, when we have enough \$1 stamps, letters will be sent out to those members not on the electoral roll and who do not have an email address.

HOW CAN YOU HELP?

If you have family members or friends who may be interested in putting the interests of the many (Public Interests) before the interests of the few (Corporate Interests), please encourage them to join and post or email their application form to PIBCI.
